Requirements:

1. Application, including Personal Particulars form, duly completed with specimen signatures.
2. Three passport size (3.5 cm x 3.5 cm) photographs- frontal view against light background.
3. Existing Passport in original and photocopies of its relevant pages.
4. Landed Paper/Work Permit/Study Permit/Immigration status and PR Card in original and copy/ies thereof. Mail applicants may send duly notarized copies of these documents(Notarized copies of both sides of PR card will be required.(Original PR card not required)
5. If passport had expired for over 6 months. Affidavit notarized by Notary Public, stating you have not applied for Canadian Citizenship
6. If applicant has applied for Canadian Citizenship Undertaking that Indian Passport will be surrendered to the Indian Consulate once you get Canadian Citizenship
7. If the passport has expired for a long time a Search Letter from the Canadian Immigration Authorities that Canadian Citizenship has not been obtained
8. If the application is sent by mail a prepaid self-addressed envelope from Fed-EX or Express Post is to be sent along with the application.
9. For Lost/Damaged passports requirements are different. Please see separate guidelines.

Timings: Applications are accepted between 9.00 a.m. and 12:00 a.m. Pick –up time is between 3 p.m. and 4.30 p.m. on the assigned day

Please read the above instructions as well as those available on our web-site carefully before you submit the application form. Individual has to bring/send photocopies of the relevant documents.
